Board of Directors Meeting  
September 9, 2025**

**CALL TO ORDER**

President Ken Barnard called the meeting to order at 3:04 p.m. at his home in Lakeshore Landings with all Board members present.

**APPROVAL OF MINUTES**

Events Chairman Rod Griffith moved to approve the minutes of the August 12, 2025 Board of Directors meeting as read by Secretary Ron Bush (2<sup>nd</sup> – Membership Chairman David Barnes).

**TREASURER REPORT**

Treasurer Jerry Danese presented the financial report for the period August 1-31, 2025. The starting balance was \$3,604.77. The chapter had receipts of \$1,534.29 and disbursements of \$759.22. The ending balance was \$4,379.84. Since September 1, \$25 in membership dues have been received. The available checking account balance is \$4,404.84. Jerry said an additional \$75 in membership dues were picked up from the Post Office on the way to the meeting, giving the club an available balance of \$4,479.84.

During August, the largest receipts were \$348.29 for Prime Timers shirts, \$300 in membership dues, \$375 in Anniversary Dinner reservations, \$155 for the Anniversary Dinner 50/50 raffle, \$145 in General meeting fees, and a \$105 50/50 raffle donation by member Bill Thomas. During August, the largest disbursements were a \$235 donation to the Orlando Gay Chorus and \$192 for the postal box rent.

**VICE-PRESIDENT REPORT**

Vice-President Jim Levasseur said he sent Stacy, Joanna and Thomas a thank you note for their presentation on wills and estate documents at the August General meeting. Jim reported no new Care Connection requests have been received and that he provided training documents to the club ambassadors. Jim said he has arranged for a representative of the Florida Department of Elder Affairs SHINE (Servicing Health Insurance Needs of Elderly) Department to talk at the September General meeting about Medicare to help prepare club members for the upcoming annual Medicare enrollment period. Jim added that the October General meeting program will be about the Medicare – Part D changes that will take effect in 2026 and the November General meeting program will be about tech security and scam protection for seniors.

**MEMBERSHIP CHAIRMAN REPORT**

Director/Membership Chairman David Barnes reported the club has 112 members as of today, September 9.

**EVENTS CHAIRMAN REPORT**

Director/Events Chairman Rod Griffith distributed copies of the schedule of activities for October. Rod reported that 23 members have RSVP'd for the dinner at the Winter Park Outback Steakhouse on September 28. He said several inquiries had been received about doing a cruise on the riverboat Barbours Lee out of Sanford. Rod also said he is looking at an outing to the Orlando Gay Chorus holiday concert in December. An outing is scheduled to see "Downton Abbey: The Grand Finale" at 11:05 a.m. Monday, September 15, at the Cinemark Orlando followed by lunch at the nearby Longhorn Steakhouse.

**PUBLICITY CHAIRMAN REPORT**

Publicity Chairman Rick Eger announced the celebrations for October. ### CALL TO ORDER

President Ken Barnard welcomed 30 members and 1 guest – Marty – to the monthly meeting at 1:01 p.m. in the theater at District Dive/Southern Nights. Also in attendance were three program presenters from Orange Blossom Law. All Board members were present. Ken said he was glad to see such a good turnout on a holiday weekend.

### PROGRAM

Vice-President Jim Levasseur introduced guest speakers Stacy Preston and Joanna Payette of Orange Blossom Law. Stacy introduced the third member of their team, Thomas Blake. For about 20 minutes, Stacy and Joanna talked about Wills and other Estate documents that everyone should have to ensure their assets go to the people they want. Their presentation was clear, simple and relatable. They also fielded questions from the members. They will give any Prime Timers members who use their legal services a 10 percent discount. Two key points from Stacy and Joanna: handwritten wills are not acceptable in Florida and Do Not Download a will, power of attorney, etc. document from the internet as Florida has very specific laws regarding Wills and other documents.

### SOCIAL TIME

Ken recessed the meeting at 1:22 p.m. so that members could partake of the food refreshments provided by members Dave Hack and Russ Mayo. When the meeting resumed at 1:41 p.m., Ken thanked Dave and Russ for arranging for the refreshments.

### APPROVAL OF MINUTES

Member Ken Frost moved to approve the minutes of the July 26, 2025 General meeting as printed in the September 2025 issue of *The Marquee*, the monthly newsletter (2<sup>nd</sup> – member Bill Thomas).

### TREASURER'S REPORT

Treasurer Jerry Danese presented the financial report for the period July 26 to August 29, 2025. The club started the period with a balance of \$6,848.56. The club had receipts of \$1,6987.29 and disbursements of \$4,186.48. The club ended the period with a balance of \$4,360.37. The largest receipts were \$420 in anniversary dinner reservations, \$375 in membership dues, \$348.29 for Prime Timers shirts, \$160 in General meeting dues, \$155 from the anni-

versary dinner 50/50 raffle, and \$105 donated by the winner of the anniversary dinner 50/50 raffle. The largest disbursements were \$3,454.60 for the anniversary dinner, \$349.19 for Prime Timers shirts, and a \$235 donation to the Orlando Gay Chorus.

### VICE-PRESIDENT'S REPORT

Vice-President Jim Levasseur had hoped to have the club Ambassadors introduced our newest club members, Orlando Ramirez and Jeff Moyer, but neither one was able to attend today's meeting. Orlando and Jeff will be formally introduced to the club at the next meeting they attend. Jim said he is working on a program about Medicare and Medicare Advantage plans. 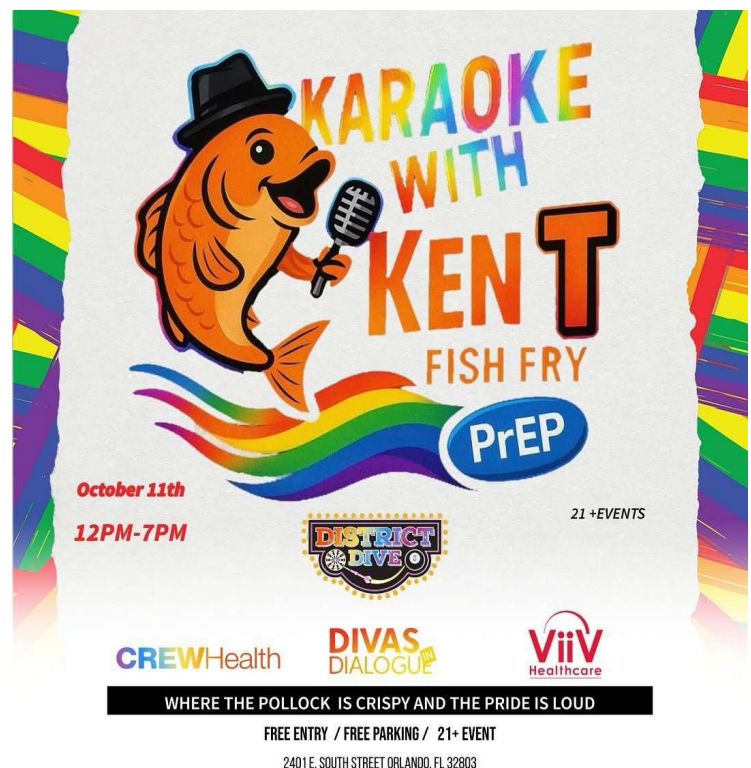
